Subject:	Champlain Parkway

On April 15, 2011, the City of Burlington and the State of Vermont Agency of Transportation filed application #4C0438-17 for a Project described as **the completion and construction of the Champlain Parkway connecting I89 to a new roadway extending to Lakeside Avenue, reconstruction and repaving of Lakeside Avenue and of Pine Street, between Lakeside Avenue and Main Street. The Project includes a new shared use path connecting Shelburne Street to Pine Street, along the new roadway and along portions of Lakeside Avenue and Pine Street.** The project is located on I89 in the Cities of Burlington and South Burlington. This Project will be evaluated by the District 4 Environmental Commission in accordance with the 10 environmental criteria of 10 V.S.A. § 6086(a).

A Prehearing Conference was held on May 19, 2011 10:00 a.m. in the conference room at the City of Burlington Public Works Dept. 645 Pine Street, Burlington, Vermont. A site visit preceded the Pre-hearing Conference. At the Pre-hearing, requests for party status were heard by the District Commission and preliminary party status decisions were made. This information was distributed by a *Pre Hearing Conference Report and Order*, dated May 23, 2011. Subsequently, three individuals requested party status after the Pre-Hearing and the District Commission granted them preliminary status. No objections were voiced by the Applicants. A revised party status table and a Certificate of Service is appended to this document.

The public hearings will be held on <u>July 26, 2011</u> to hear testimony under Criteria 1B, 1E, 4, 7, 9A, 9K (non traffic) and 10; <u>August 23, 2011</u> to hear testimony under Criteria 1 (air) and 8 and on <u>August 31, 2011</u> to hear testimony under Criteria 5 and 9K (traffic). All hearings to be held starting at <u>6</u> <u>PM at Contois Auditorium</u> 149 Church Street, Burlington, VT, Vermont.

The District Commission hereby orders the following documents:

- 1. Any testimony to be provided by expert witnesses must be distributed to the District Commission (4 copies plus a digital version) and to all parties who have status under that criterion no later than 10 days prior to the start of that hearing (July 18, 2011, August 15, 2011 and August 22, 2011, respectively - due to weekends)
- 2. All parties not utilizing expert witness shall be prepared to give testimony on the date of their hearing.
