Re: Lake St. Catherine Pesticide Permit Public Meeting Notification

This is notification that an in-person and virtual public meeting will be held on November 20, 2024 from 4:30 p.m. – 6:30 p.m. for Aquatic Nuisance Control Draft Permit #4233-ANC-C for the Eurasian watermilfoil control project in Lake St. Catherine in accordance with the permit process as identified under [10 V.S.A. Chapter 170](#). Notice of the administratively complete Aquatic Nuisance Control applications occurred on March 27, 2024. The proposed project is for the chemical control of Eurasian watermilfoil in Lake St. Catherine in the towns of Wells and Poultney. The purpose of the meeting is for the VT Agency of Natural Resources and the applicant (Lake St. Catherine Association and SOLitude Lake Management) to provide basic information about the draft permit decisions and provide an opportunity for members of the public to submit questions to the applicant, the Agency, and provide oral and written comments.

The meeting will be held both in person and on Microsoft Teams. The in-person meeting will be held at the Town of Wells Town Clerks Office, located at 1064 VT-30, Wells, Vermont, 05774.
