Amended Mechanical Harvesting Proposal

There has been mechanical harvesting of aquatic nuisance plants of aquatic nuisance plants on Lake Bomoseen over the 40 or so years in order to open maintain navigation channels. Such nuisance plant harvesting on Lake Bomoseen north of the Grady Bridge has been conducted for decades by a joint effort between the friends up North, a group of homeowners north of the Grady Bridge, and the Town of Hubbardton, most recently under ANC permits 2005-H02 and 2015-H02 ("The Harvesting Program")

We propose to continue the Harvesting program in the same fashion as under the last issued permits. Specifically, we will continue to remove aquatic nuisance plants along the shoreline of Lake Bomoseen and in various navigation lanes north of Grady Bridge with the same Aquamarine Mechanical Harvester that has been employed for the last decade or longer. This harvester is relatively small. The harvester's shallow draft, and maneuverability, allows us to remove aquatic nuisance plants closer to the shoreline. The proposed harvesting activity is intended to control EWM by reducing its volume within the upper 4 feet of the water column, from the shoreline and into well established navigation lanes. Multiple harvestings throughout the growing season are anticipated, beginning on July 1 and continuing through September. Skimming will be conducted as well. Skimming removes floating debris, which may include fragments created by the harvester and boating activities. The removal of these masses and fragments will help mitigate the spread of aquatic nuisance plants and allow boating enthusiasts and fishermen better access to open water.

Harvested vegetation will be off-loaded into a truck, transported to land and non-wetland locations, where it will be composted.

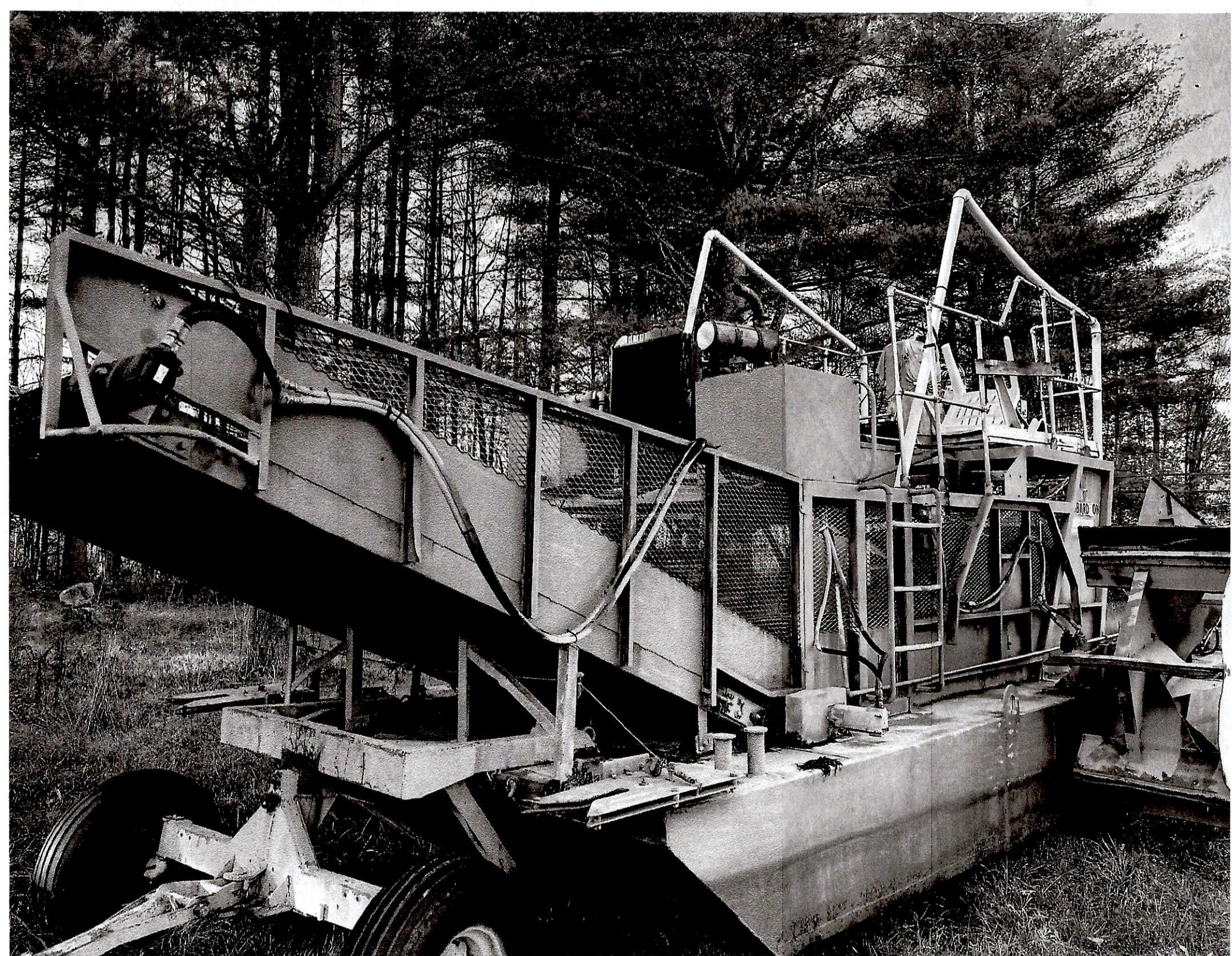
Proposed Harvest Area

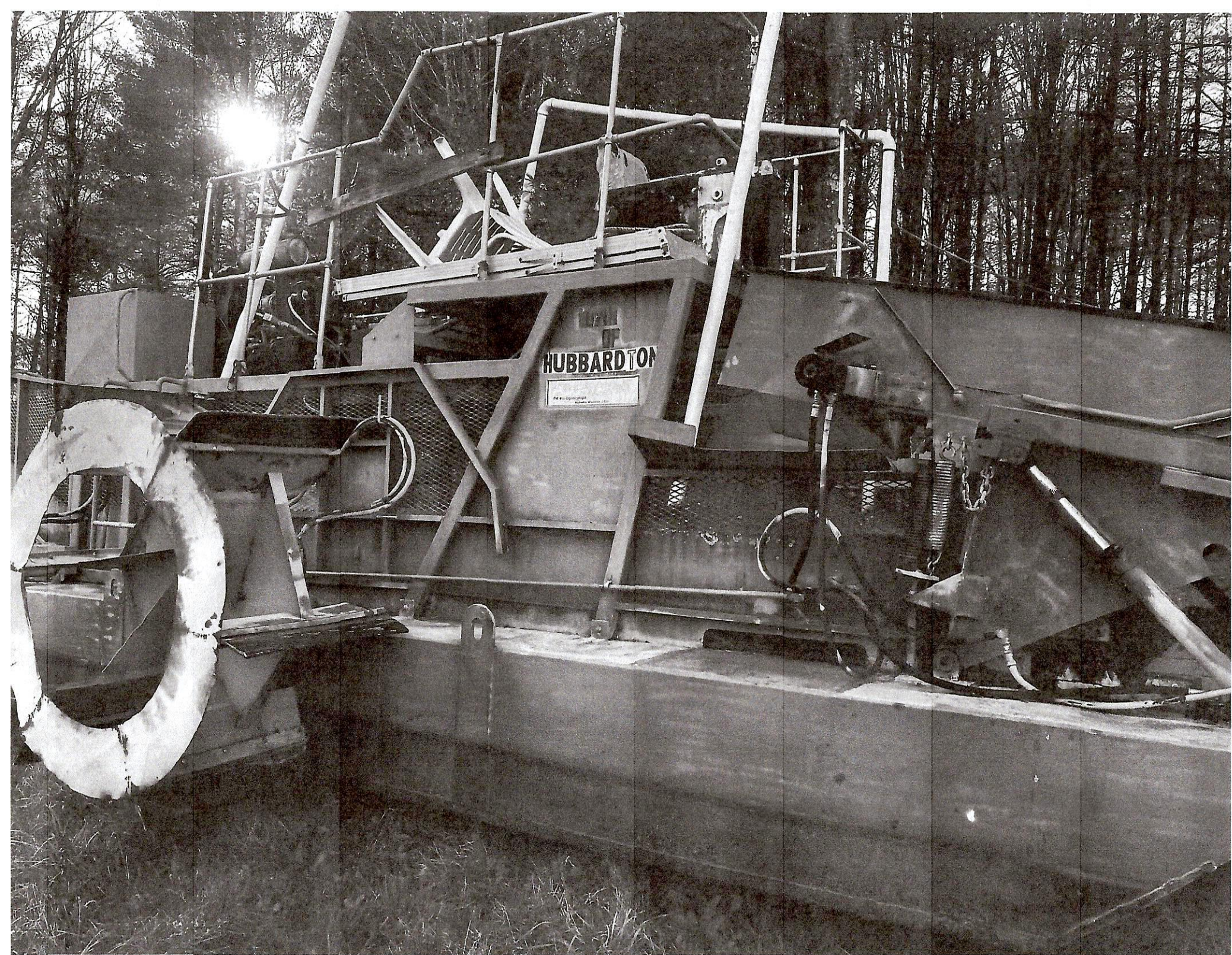


Lake Bomiseon
